# Minutes of the Meeting held on Wednesday 11<sup>th</sup> March 2020 at 8.00 pm

#### 1. Apologies for Absence

Parish Councillors: Jonathan Murphy, Stephen Meredith, Jenny Wicks and Guildford Borough Councillors Tim Anderson and Catherine Young were not present.

#### 2. **Declaration of Interests**

Terence Patrick declared that he was an Honorary Alderman in the Borough of Guildford and member of the Village Hall Management Committee. Chris Dean is a member of the Village Hall Management Committee. Eric Palmer is the Chairman of the Clandon Society.

#### 3. Minutes of the Meeting held on 12/02/2020

It was noted at Minute Number 7 an incorrect spelling was recorded for Cllr Chris Dean. Following a correction from Christ to Chris, the Minutes of the meeting were agreed as a correct record and signed by the Chairman.

#### 4. Matters arising from February 2020 Minutes

- Cllr Dean reported that the manhole cover outside the property known as Dibbles has been removed and traffic lights are now controlling traffic in a one-way system outside the property.
- Cllr Edwards reported that he had contacted Adrian Thompson Chair of Guildford Environment Forum (GEF) with regard to GEF giving a talk on 'How should Guildford react to the Climate Emergency'. It was proposed that the talk may be appropriate to be given at the forthcoming East and West Clandon Residents Association.

**RESOLVED**: Cllr Edwards AGREED to speak further with Adrian Thompson.

### 5. Appointment of West Clandon Parish Clerk and RFO

The Chairman reported that Mrs Fiona Gilbert has confirmed her acceptance to the offer of appointment as Parish Clerk and RFO and will commence employment on 1st May 2020. The Locum Clerk AGREED to extend her temporary position from 31/03/2020 to 30/04/2020. **RESOLVED**: all Councillors AGREED.

## 7. Local Plan Update

Cllr Dean reported there was no update.

## 8. West Clandon Neighbourhood Plan

Cllr Dean reported that the consultation is open until the end of March 2020. The Clerk reported that a number of comments had been received via the Clerk's e-mail address. These had been forwarded onto John Stone.

#### 9. Financial Matters and Approvals

- (a) The Chairman reported on the financial transactions since the 12/02/2020 meeting:
  - £8,255.40 Playforce first instalment of the new playground equipment
  - £269.59 Nuture routine February 2020 recreation ground maintenance

**RESOLVED**: Councillors AGREED the above payments.

It was noted the balance in the Unity Bank Account was £4,168. Cllr Meredith suggested that the Council may have to draw down to pay the second stage of the Playforce project bill. This will depend on the invoice being submitted before receipt of the April instalment of the precept.

- (b) The Chairman reported that there were three Parish Council Policies to update.

  - ii. Internal Audit Terms of Reference
  - iii. Internal Audit Effectiveness Review for the year ending 31/03/2020

**RESOLVED**: All Councillors AGREED that there was no requirement to change the wording.

#### 10. Recreation Ground

#### Playground and Car Park:

Cllr Palmer reported that all the trees are in a Conservation Area and the works would not be completed by Mr Cormack until the end of April 2020.

#### Playground:

Cllr Palmer reported that the current play frame would be removed on 21/03/2020. New fencing and the goal posts would be moved on 30/03/2020. Cllr Palmer has been asked to arrange for a 'portable loo' for the contractors. Due to the hiring cost, Cllr Palmer will arrange for the contractor to use the facilities in the Village Hall. He reported that Nurture cannot access the 5-bar metal gate and there is no key available for the padlock. It was suggested that a local locksmith may be able to cut the padlock and Cllr palmer will investigate this option.

#### Playground Inspection

Cllr Palmer reported that the roundabout has been categorised as being in the top area of medium risk. The quote for a 4-person new roundabout was £3,600, plus £2,700 for new surface. Cllr Palmer suggested that the Parish Council wait until the grant is awarded from iGas and Guildford Borough. Council.

**RESOLVED**: Defer the decision to replace the roundabout until the next meeting on 08/04/2020.

#### 11. Footpaths

Cllr Edwards reported that footpath number 568 is under water as the ditch is blocked. Cllr Taylor confirmed that the landowners are responsible for dealing with such matters. Cllr Edwards reported that Surrey County Council have forwarded several names of contractors who would be able to clear the culvert.

**RESOLVED**: Cllr Edwards to obtain some quotes.

A discussion took place with regard to the bridge and flooding at the end of Green Lane. Cllr Edwards reported that there is a query over land ownership.

No matters were discussed or noted.
