1	Bob Hughes	11 th May 2023	Conveying a resident's query on the draining impact of the roadworks currently on Tithebarns Lane. BH responded noting that he would query this and the 40mph request with Surrey Highways.
2	SCC	18 th May 2023	Submission of form to apply for a grant from Bob Hughes' Members Community Allocation Fund to help fund a replacement perimeter fence at our recreation ground.
3	Residents/ Council informal horticultural liaison group	19 th May 2023	Notification that the Clerk has cleared vegetation around 3 recently-planted trees on the bank opposing the entrance to Meadowland and request to confirm whether the volunteers can water them and the 2 new trees at the Meadowlands entrance over the summer. Also, to ask for suggestions as to tree planting and soft landscaping on the bank once to new Recreation ground perimeter fencing is installed.
4	West Clandon RBL	20 th May 2023	Letter thanking the RBL for organizing and executing the major community event in the parish on 7 th May for the Coronation weekend and for providing refreshments for our volunteering morning on 8 th May.
5	West Clandon GoogleGroups email network	6 th June 2023	Request to help understand historic usage of a footpath parallel to Staple Lane that has recently been fenced off.

1	Village Hall Management Committee	8 th May 2023	Cheque received for contribution to carpark resurfacing.		
2	GBC	9 th May 2023	Notification that there is a consultation open to us on a revised Animal Licencing Policy.		
3	SALC	10 th May 2023	Notification that the Government are currently running a Technical Consultation on the proposed infrastructure Levy (IL).		
4	SALC	10 th May 2023	Encloses a welcome letter to all our councillors and offers of training, advice and guidance.		
5	GBC Councillor Catherine Young	12 th May 2023	Provided an update on the Garlick's Arch pylons: GBC Planning has agreed for the burying of the electricity cabling to be deferred to Phase 2 of the development. CA also noted that she is attending a briefing on the Gosden Hill development shortly and will report back to us.		
6	Gary Durrant, GBC Environmental Protection	15 th May 2023	In response to BH's raising of the noise issues from a pack of dogs off Lime Grove, GBC are offering to conduct some monitoring but need a local resident to act as receptor. Receptor has now been found and will complete an online noise complaint with GBC.		
7	Gosden Hill Community Team	18 th May 2023	Letter providing an update on Martin Grant Homes' Gosden Hill proposal. They have now submitted to Guildford Borough Council a request for an Environmental Impact Assessment (EIA) scoping opinion for the scheme and this has now been registered. The Gosden Hill Community Team is working on behalf of Martin Grant Homes and co-ordinating community outreach work and public consultation events. Over the summer, they will be holding briefings, workshops and consultation events on the proposal and look forward to meeting elected members, community groups, local residents and businesses. The Clerk has subsequently liaised with the team and they have agreed to attend our PC meeting on 12 th July.		
8	GBC Planning	26 th May 2023	Notification that the appeal against GBC's non-determination of the planning application for Land at Wisley Airfield has commended and we are invited to make comments by 26th June.		
9	Tithebarns Lane Resident	30 th May 2023	Email concerning the traffic flow in Tithebarns Lane. The long-term resident has seen not only an increase in traffic movements but an increase in the number of heavy trucks plus seemingly impatient drivers. He believes that this has contributed to the increase in recorded, and un-recorded, accidents as well as near encounters at the slip-road to Clandon Road junction and at the narrow bridge to Tithebarns Lane. He is also concerned that the recent changes at the sliproad junction have had a negative impact on the smooth flow of traffic at busier times. Notably, the traffic coming along the A247 from Clandon to turn right down the slip-road to Guildford has to wait longer to see whether Burnt Common traffic is turning down the slip-road and as a consequence a queue develops. Additionally, he now sees a		

			queue at the top of Tithebarns Lane as vehicles wait to join the A247, a situation which he hadn't experienced before.
